Under the Payment of Contributions Regulations of the Pensions Act 1990, as amended, employers are required to remit contributions due to a pension scheme within 21 days of the end of the month to which the contributions apply (e.g. contributions due for the month of January must be remitted to the Scheme by 21<sup>st</sup> February). Failure to pay contributions on time will result in an arrears rate being applied to any unpaid contributions as per Rule 4.9 of the Scheme's Trust Deed & Rules.

#### **Death-in-Service Benefits**

A Death in Service benefit of 0100,000 plus the value of the member's account is payable to the next of kin of a deceased member, provided that, at the time of death, all contributions due in respect of the member are paid up to date and at least 26 contributions in respect of the member has been paid to the Scheme.

An additional €3,175 for each eligible child is also payable. Death in Service cover is extended to age 66 for active members.

#### **Sick Pay Benefit**

Sick Pay benefit is payable at a rate of €38.11 per day (€190.55 per week) for a maximum of 50 working days in a calendar year. Sick Pay benefit cover is extended to age 66 for active members.
